Secretary Dauner advised that the high bid through Auctions International on the 1992 Beck was \$7,100.00. A motion was made by Commissioner McNamara, 2<sup>nd</sup> Commissioner Sammons to accept bid of \$7,100.00 for 1992 Beck. Discussion followed. Commissioner Spinnenweber felt that the bid was low and there were more options out there. She stated that there are fire auctions available. Secretary Dauner stated that the district in the past has used companies such as Adirondack Fire Equipment and struggled to get a favorable price on the past several trucks sold. He stated that the ladder sold for \$20,000.00 Discussion continued and Commissioner Spinnenweber stated that Jack Spinnenweber Sr and Jack Spinnenweber Jr offered try to find a buyer to purchase and if it does not sell, they will purchase from the district for \$7,200.00. The board stated they would wait until the next board meeting when other board members are present to make a decision. Secretary Dauner will notify Auctions International and ask they hold the bid until the next meeting. The board stated the apparatus can be placed outside at the Chiefs' discretion to make room for other apparatus.

Treasurer Trojak addressed the NYS Retirement System proposal for the Treasurer and the Secretary. It would cost approx. \$3,203.00 each year for moving forward effective the date of the resolution. She stated that years of service credit would start effective the date of resolution and due to this, neither her or the Secretary are in favor and would rather see the money go towards salaries in the future.

Treasurer Trojak suggested the board consider LOSAP salary with Ron Naccarato's pending retirement, new members recently added to the department, increasing trainings and conventions line with new state and federal mandates coming out, and increasing postage.

At this time the board reviewed the 2025 proposed budget submitted by Treasurer Trojak and reviewed line items for adjustment. See attached copy.
